Please take note that on 30 July 2025 the High Court made an injunction order (the "Order") against you and the other stated defendants restraining you from acts of trespass and/or private nuisance on the land shown edged in red (excluding the land shaded blue) on the plan appended to the Claim Form, as well as an order for alternative service. You should read the Order in full and in particular the penal notice on pages 1 and 2.

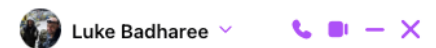

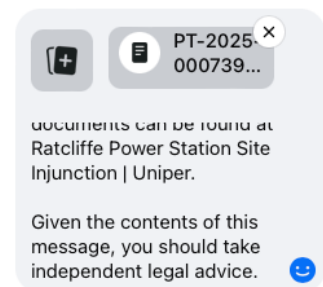
