2. Cookie-settings on uniper.energy and subpages

Cookies and similar technologies are used on this website.

Cookies are small text files that your browser automatically creates and that are stored on your end device (computers, tablet, smartphone or similar). In the cookie, information is stored that arises in each case in connection with the specific end device used. This does not mean, however, that we thereby gain immediate knowledge of your identity. Some of the cookies we use are deleted at the end of the browser session (so-called session cookies). Other cookies remain on your computer and enable us to recognize your computer on your next visit (so-called permanent or cross-session



cookies). These cookies in particular serve, among other things, to make our offer more attractive to you.

According to legal requirements, the storage of information on end devices (computers, smartphones, tablets or similar) - e.g. by setting cookies - as well as the retrieval of information from end devices (tracking) is generally only permitted if you have given your prior consent. The legal basis for this is Section 25 (1) sentence 1 TTDSG in conjunction with Art. 6 (1)(1)(a) GDPR. However, consent does not have to be granted if such storage/retrieval is necessary for the website offering, Section 25 (2) number 2 TTDSG. Necessity is given, for example, with regard to ensuring the following functionalities/achieving the following purposes:
